SAFETY RULES AND REGULATIONS

These rules have been established for the safety of our guests, staff and neighbors. Safety is our highest priority. We shall enforce these rules to avoid serious injury to persons or property. Should you see someone violating any rule, we ask that you immediately bring any violation to the attention of the nearest range safety officer (RSO).

Gun Handling Rules:

- The only shotgun gages allowed are 12, 16, 20 28, 410
 - All other firearms are not permitted
- Keep guns pointed in a safe direction and NEVER at another person
- Keep gun open at all times unless in shooting stand
- Always keep your finger off the trigger while outside the shooting stand
- Never load the gun until you are in the shooting stand
- Always unload the gun before leaving the shooting stand
- Shooting outside the shooting stand is strictly prohibited
- Only one shooter is allowed in the shooting stand at any given time

General Rules:

- Always wear ear and eye protection while on the course or around the 5 stand area
 - This applies to everyone – spectators, staff , trappers and shooters
- Only designated staff are allowed to adjust, move, clear or otherwise handle the clay target machines
- The only shot sizes allowed are 7 ½ , 8, 8 ½ , and 9
- Rough Riders and Tampa Bay Sporting Clays reserve the right to inspect and approve all loads
- Alcohol and drugs are strictly prohibited on the property
- Everyone must stay on the designated course trails at all times
- Harvesting of any game is prohibited
- Each squad is allowed one review pair per station.
 - Any excess targets will be charged accordingly
- Shooters must be at least 16 years old and hold a valid driver's license
- All minors under the age of 16 years old must be accompanied by a parent or legal guardian
- Any damages to golf carts will be the responsibility of the person renting or reserving the golf cart

If you are in doubt about any rule or regulation, please consult a member of either the Rough Riders or Tampa Bay Sporting Clays staff.

IN CONSIDERATION of being given the opportunity to participate in any way in the 1st U.S. Volunteer Cavalry Regiment "Rough Riders" Sporting Clays Tournament, I, ("I" is for myself and/or my minor child as used hereinafter), my or my minor child's personal representatives, assigns, heirs, and next of kin:

1. ACKNOWLEDGE, agree and represent that I understand the nature of the activity of shooting sporting clays, either as a sole participant or as a participant in a tournament of sporting clays. I further acknowledge that I am qualified, in good health, and in proper physical condition to participate in such activity. I further agree and warrant that if, at any time, I believe any conditions to be unsafe, I will immediately discontinue further participation in this activity.

2. I FULLY UNDERSTAND that: (a) THE SHOOTING OF SPORTING CLAYS AND/OR ACTIVITIES SURROUNDING SAME INVOLVES RISKS AND DANGERS OF SERIOUS BODILY INJURY INCLUDING PERMANENT DISABILITY, PARALYSIS, AND DEATH ("RISKS"); (b) these Risks and dangers may be caused by my own actions or inactions or the actions or inactions of other participants in the activity, the condition in which the activity takes place, or the negligence of the releasees named below; (c) there may be other risks and social and economic losses either not known to me or not readily foreseeable at this time and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I incur as a result of my participation in this activity.

3. I HEREBY RELEASE, DISCHARGE AND COVENANT NOT TO SUE, Tampa Bay Sporting Clays, and the 1st U.S. Volunteer Cavalry Regiment "Rough Riders", Inc., their administrators, directors, agents, officers, members, volunteers, members of the Rough Riders Sporting Clays Committee, any employees, other participants, any sponsor, advertisers, and, if applicable, owners and lessor of the premises on which the activity takes place (that each of the above shall be considered RELEASEES herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED, IN WHOLE OR IN PART, BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE INCLUDING NEGLIGENT RESCUE OPERATIONS; AND I FURTHER AGREE THAT despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF THE RISK AND INDEMNITY AGREEMENT, that if I, or anyone on my behalf, makes a claim against any of the releasees, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS AND DEFEND EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability damage or cost which may be incurred as a result of such claim.

NOTICE TO THE MINOR CHILD'S NATURAL GUARDIAN

READ THIS FORM COMPLETELY AND CAREFULLY. YOU ARE AGREEING TO LET YOUR MINOR CHILD ENGAGE IN A POTENTIALLY DANGEROUS ACTIVITY. YOU ARE AGREEING THAT, EVEN IF TAMPA BAY SPORTING CLAYS, THE 1ST U.S VOLUNTEER CAVALRY REGIMENT "ROUGH RIDERS", INC. YOU HAVE THE RIGHT TO REFUSE TO SIGN THIS FORM, AND TAMPA BAY SPORTING CLAYS, THE 1ST U.S VOLUNTEER CAVALRY REGIMENT "ROUGH RIDERS" AND THE ROUGH RIDERS SPORTING CLAYS TOURNAMENT COMMITTEE HAS THE RIGHT TO REFUSE TO LET YOUR CHILD PARTICIPATE IF YOU DO NOT SIGN THIS FORM.
